What Does Verification Mean?

Verification is the process used to check the accuracy of information submitted by students on their financial aid application. The Federal Processor chooses student applications for verification at random through computer edits. The U.S. Department of Education requires that colleges check the accuracy of the information provided on the 2024-2025 Free Application for Federal Student Aid (FAFSA) or the Renewal Application. We must verify this information before you are awarded financial aid. If there are differences between your FAFSA and this information (including your federal tax return), we will update your application and recalculate your eligibility.

Identity and Statement of Educational Purpose (To Be Signed in the Presence of a Notary)
